#### Acknowledgement of Declaration, Bylaws and Rules and Regulations

I/we hereby acknowledge that the Declaration (CC&R's), Bylaws and Rules and Regulations of the Association constitute a contract between the San Ignacio Villas HOA and me/us (the owner). By signing this statement, I/we acknowledge that I/we have read and understand the Association's contract with me/us (the owner). I/we also understand that as a matter of Arizona law, if I/we fail to pay my/our association assessments, the Association may foreclose on my/our property.

#### Owner Age Verification:

As a Property Owner's Association in Arizona classified as 55 years of age or older, we are required by law to survey and certify that the Association is in compliance.

Per Article 16, Section 16.6 - Age Restrictions of the CC&R's, San Ignacio Villas Inc. HOA is an age restricted community. In order to maintain this exemption, at least one residing occupant must be 55 years of age or older. No person under the age of 18 shall reside "permanently" in a residence. "Permanent" is considered more than 90 days in any twelve-month period.

If at any time you rent out your property, your tenant(s) must also abide by the above. If you are placing your property with a Rental Agency/Property Management Company you are responsible to insure compliance with the age restriction. Additionally, your advertising media (VRBO-Airbnb-Website, etc.) must clearly state the 55+ age restriction.

By signing below, I/we hereby verify that I/we understand this exemption, I/we acknowledge that I/we have received the SIV HOA Declarations, Bylaws and Rules and Regulations, I/we and/or our tenants will abide by the SIV HOA Declarations, Bylaws and Rules and Regulations.
